Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 10, 2025, placed the rating(s) of Coromandel Agrico Private Limited (CAPL) under the 'issuer non-cooperating' category as CAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 24, 2026, March 06, 2026, March 16, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

CAPL was incorporated in 1998 and is engaged in manufacturing of agro chemical products. The company has 3 manufacturing facilities at Sikandrabad, Baroda – Nandesari (Gujarat) and Chiplun Lote (Maharashtra). Incorporated in 1973, ACL is engaged in the same line of business. It has two manufacturing facilities, at Taloja (Mumbai) and Sikandrabad (Uttar Pradesh).

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of CAPL into Issuer Not Cooperating category vide press release dated February 17, 2026 on account of its inability to carry out a review in the absence of requisite information.
