Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 11, 2025, placed the rating(s) of MDJ Texco Fab Private Limited (MTFPL) under the 'issuer non-cooperating' category as MTFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MTFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 25, 2026, March 07, 2026, March 17, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings of MTFPL have been revised on account of non-availability of requisite information.

M.D.J. Texco Fab Private Limited (MTFPL), based in Karnal, Haryana was incorporated in February 2013 as a private limited company with Mr. Ajay Kumar Jain and Mr. Vijay Kumar Jain as its directors. MDJ is engaged in manufacturing of polar fleece blankets and bedsheets at its manufacturing facility located in Karnal, Haryana.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of MTFPL into Issuer Not Cooperating category vide press release dated May 21, 2025 on account of its inability to carry out a review in the absence of requisite information.
