Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 24, 2025, placed the rating(s) of SHM Shipcare (SS) under the 'issuer non-cooperating' category as SS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 10, 2026, March 20, 2026, March 30, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of SS have been revised on account of non-availability of requisite information.

About the Firm

SHM Shipcare (SS) is a partnership firm established in 2001 by Mumbai based Mr. Saifuddin Hajee. SS is engaged in ship chandlery business. The firm supplies and services marine & offshore safety equipment ranging from High Speed FRP (Fibre Reinforced Plastic) Boats, Rescue Boats, Rafts, Fire Extinguishers, Breathing Sets, Gun Metal Fittings, etc.; life-saving appliances such as Lifejackets and Lifebuoys, communication and navigation equipment for several government agencies (Indian Navy, Border Security Force, Mumbai Port Trust, JNPT, etc.) and private players.

Status of non-cooperation with previous CRA: ICRA has continued the rating assigned to the bank facilities of SS into ISSUER NOT COOPERATING category vide press release dated March 27, 2025 on account of its inability to carry out a review in the absence of requisite information from the firm.
