Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 07, 2025, placed the rating(s) of Kumar Arch Tech Private Limited (KATPL) under the 'issuer non-cooperating' category as KATPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KATPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 21, 2026, March 03, 2026, March 13, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of KATPL have been revised on account of non-availability of requisite information.

About the Company

Udaipur (Rajasthan) based KATPL was incorporated in 1998 by Mr. Vijay Lal Agarwal and Ms. Kanta Agarwal. Later, other family members and associate concerns of the promoters also became shareholders in the company and currently Mr. Shubham Taylia, Ms Shakun Taylia and Ms Surbhi Jitendra Kumar Taylia look after overall affairs of the company. Initially, KATPL was engaged in the business of manufacturing of PVC sheets. It has expanded its business and currently offers PVC doors & frames along with PVC based building material, PVC based signage material, decorative items and PVC based other products. It has three operational units located at Gudli Industrial Area, Udaipur.

Status of non-cooperation with previous CRA: ICRA has moved the rating assigned to the bank facilities of KATPL into Issuer Not Cooperating category vide press release dated September 30, 2025, on account of its inability to carry out a review in the absence of requisite information.
