Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 27, 2025, placed the rating(s) of Mercator Oil & Gas Limited (MOGL) under the 'issuer non-cooperating' category as MOGL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MOGL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 13, 2026, January 23, 2026, February 02, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Mercator Oil and Gas Ltd (MOGL), a wholly-owned subsidiary of Mercator Limited was incorporated in 2005 in India with the main business of providing oil & gas services. Arbitration proceeding against ONGC to the tune of \$252 million has adversely affected the company. Post the termination of the only available contract with the company, there has been no business activity carried on by MOGL.
