Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 24, 2025, placed the rating(s) of S. S. Nath & Company (SSNC) under the 'issuer non-cooperating' category as SSNC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSNC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 10, 2026, March 20, 2026, March 30, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The firm is engaged in operating multi-brand readymade garments showrooms in Chandigarh, Mohali and Panchkula under the brand name of 'Meena Bazaar' and 'Aliyana'. All the showrooms are currently engaged in the retail trade of readymade garments and houses renowned brands of men's, kids and women's wear like Tommy Hilfiger, Reebok, Van Heusen, Adidas, Levis, Gini & Jony, Pepe, Zardozi, Sanskriti, etc. Besides this, the firm is also engaged in the trading of bridal wear and ethnic clothing which are sourced from local manufacturers.
