Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated May 12, 2025, placed the rating(s) of Shree Bhawani Lumbers (SBL) under the 'issuer non-cooperating' category as SBL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SBL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 28, 2026, April 07, 2026, April 17, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the Firm

Gandhidham-based (Gujarat), Shree Bhawani Lumbers (SBL) is a partnership firm established in 2003 by Mr. Satish Goyal. The firm imports round timber logs from overseas countries which is subsequently sawn and sized at its saw mill into various commercial sizes as per the requirement of its customers. The facility is located at Gandhidham in Kutch district of Gujarat with a total sawing capacity of 3800 cubic feet per day as on March 31, 2017. The timber processed by SBL finds its application in packaging of various products apart from use in infrastructure, building construction, interior designing, woodwork, transportation and furniture.
