Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 02, 2025, placed the rating(s) of KNK Projects Private Limited (KPPL) under the 'issuer non-cooperating' category as KPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 16, 2026, February 26, 2026, March 08, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of KPPL have been revised on account of non-availability of requisite information.

About the Company

New Delhi, Delhi based KNK Projects Private Limited (KPPL) was incorporated in March, 2016 as a private limited company. The company is currently being managed by Mr. Shankar Khandelwal, Mr. Nishant Khandelwal and Mr. Nikhil Khandelwal. The company undertakes water supply contracts for setting up of water supply systems, laying of water supply distribution networks, wastewater treatment plants on turnkey basis (design, construction, supply, installation, testing and commissioning) and its operation & maintenance related works mainly for government departments like Public Health Engineering Department, (Haryana), Madhya Pradesh Urban Development Company Limited, (Madhya Pradesh), Madhya Pradesh Jal Nigam (Madhya Pradesh), Department of Water Supply & Sanitation (DWSS) (Punjab), etc. In order to get the business, company has to participate in tenders floated by government companies. The company has geographical coverage across Haryana, Madhya Pradesh and Punjab. The company is having a joint venture partnership firm namely, "M/s KNK JWIL JV". It is a joint venture between "M/s KNK Projects Private Limited" and "M/s JWIL Infra Limited" having 60:40 ownership.
