Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 03, 2025, placed the rating(s) of AL-Falah Frozen Foods (AFF) under the 'issuer non-cooperating' category as AFF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AFF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 17, 2026, February 27, 2026, March 09, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the Company

Uttar Pradesh based AL-Falah Frozen Foods (AL-Falah) was established in the year 2005 as a partnership firm. The firm is currently being managed by Mr. Shakeel Ahmad, Mohammad Sameer and Mr. Tashkil Ahmed. The firm operates as an integrated cold chain and preservation facility and is engaged in the processing and supplying of frozen buffalo meat. The processing facility of the firm is located at Moradabad, Uttar Pradesh and has its own slaughterhouse with a capacity to process 500 buffalo per day. However, they have permission to process 150 buffalo per day as on March 31, 2022. The firm is having three associate concerns namely; "AL-Falah Cold Storage" (established in 2016) operates as cold storage; "AL-Falah Food Exports" (established in 2015) engaged in the trading of processed meat and "AL-Falah Foods Private Limited" (incorporated in 2019) engaged in the export of processed meat.
