### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 11, 2025, placed the rating(s) of Meet Associates Private Limited (MAPL) under the 'issuer non-cooperating' category as MAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 25, 2026, March 07, 2026, March 17, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Further in October 2010, the company was awarded dealership for LCV & PV by M&M. The company was promoted by Mr. Baldev Singh and subsequently taken over by his son Mr. Narendra Singh. The company operates two 3S facilities of Mahindra & Mahindra Ltd in Sultanpur (Uttar Pradesh) and one 3S facility of Honda Motorcycle and Scooter India Pvt. Limited in Moga (Punjab).
