### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 04, 2025, placed the rating(s) of Shree Krishna Educational & Charitable Society (SKECS) under the 'issuer non-cooperating' category as SKECS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SKECS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 18, 2026, January 28, 2026, February 07, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the Society

Shree Krishna Educational and Charitable Society (SKECS) got registered under the Society Registration Act – 1860 in 2008 and is currently being managed by Mr. R.K. Gupta, Mr. Vicky Singhal and Mr. Inderpal Goyal. The society was formed with an objective to provide higher education in the field of engineering, computer science, management, agriculture etc. The society has established two separate colleges, namely, Aryabhata Engineering College and Aryabhata Group of Colleges. Both the colleges of SKECS are in Barnala, Punjab.

**Status of non-cooperation with previous CRA:** India Ratings has continued the rating assigned to the bank facilities of SKECS into Issuer Not Cooperating category vide press release dated March 04, 2026, on account of its inability to carry out a review in the absence of requisite information.

CRISIL has continued the rating assigned to the bank facilities of SKECS into Issuer Not Cooperating category vide press release dated May 15, 2025, on account of its inability to carry out a review in the absence of requisite information.
