Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 04, 2025, placed the rating(s) of Gyaneshwar Saran Sudeshwar Saran And Co. (GSSSC) under the 'issuer non-cooperating' category as GSSSC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GSSSC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 18, 2026, February 28, 2026, March 10, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings. has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
