### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 12, 2025, placed the rating(s) of Intex Technologies (India) Limited (ITL) under the 'issuer non-cooperating' category as ITL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ITL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 26, 2026, February 05, 2026, February 15, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Incorporated in the year 1996, Intex Technologies (India) Limited was managed by Mr. Narendra Bansal, Managing Director. The company is engaged in the assembling, manufacturing, and trading of mobile handsets, computer peripherals, multimedia speakers, personal computers, and consumer electronics under the brand name of 'INTEX'. The company primarily operates in three business segments namely mobile handset, Consumer Electronics (DVD player, TV, LCD etc.) and IT Hardware (UPS, Monitor, Keyboard, Mouse, and other computer peripherals).

**Status of non-cooperation with previous CRA:** Infomerics has continued the rating assigned to the bank facilities of ITL into Issuer Not Cooperating category vide press release dated September 22, 2025 on account of its inability to carry out a review in the absence of requisite information.
