Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 22, 2025, placed the rating(s) of Comet Granito Private Limited (CGPL) under the 'issuer non-cooperating' category as CGPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. CGPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 08, 2026, March 18, 2026, March 28, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the Company

Comet Granito Private Limited (CGPL) is a Morbi based entity, promoted by the Bhalodiya family. Incorporated in September 2006, CGPL is engaged in manufacturing of glazed vitrified tiles. CGPL undertook an expansion cum modernization project in FY15 and commenced commercial production from June 2015. CGPL markets its products under the brand 'Comet' and 'Granicer'.

Status of non-cooperation with previous CRA: Infomerics has continued the ratings assigned to the bank facilities of CGPL to the 'issuer not-cooperating' category vide press release dated April 29, 2026 on account of its inability to carryout review in the absence of requisite information from the Company.
