### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 25, 2025, placed the rating(s) of R B A Construction Private Limited (RBACPL) under the 'issuer non-cooperating' category as RBACPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RBACPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 08, 2026, February 18, 2026, February 28, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of RBACPL have been revised on account of non-availability of requisite information.

### About the company

Rohtas, Bihar based R B A Constructions Private Limited (RBACPL) (CIN No. U45200BR2003PTC010093) was incorporated in February, 2003. The company is currently promoted by Mr. Amit Pandey, Mr. Ravi Kant Pandey and Mrs. Bimla Pandey. The company is "Class A" contractor and is engaged in civil construction works such as construction of roads and bridges mainly for government departments like Road Construction Department, Bihar, Department of Road Construction, Jharkhand, Road Construction Department of Uttar Pradesh and other local government bodies.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of RBACPL under Issuer Not Cooperating category vide press release dated July 23, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm
