### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated March 13, 2025, placed the rating(s) of Om Shiv Lumbers Private Limited (OSLPL) under the 'issuer non-cooperating' category as OSLPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OSLPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 27, 2026, February 06, 2026, February 16, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

### About the company

Gandhidham-based (Gujarat), OSLPL was incorporated in March 2012 by Mr. Deepak Khatwani and Mrs. Bhagwati Khatwani. It is engaged in trading and processing of timber products namely wooden plates, face veneers, ready pallates, etc. OSLPL also perform job work for log dimension setting. At present, 27 employees are working under the company. There are 3 sets of vertical and horizontal sawing machines with installed capacity of 1500 cubic feet per day. Both the machineries and factory premises are rented.
