Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 17, 2025, placed the rating(s) of Lodhi Rajpoot Ice And Cold Storage Private Limited (LRICSPL) under the 'issuer non-cooperating' category as LRICSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. LRICSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 31, 2026, February 10, 2026, February 20, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
