### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated February 26, 2025, placed the rating(s) of Sadbhav Kim Expressway Private Limited (SKEPL) under the 'issuer non-cooperating' category as SKEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SKEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 12, 2026, January 22, 2026, February 02, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SKEPL have been revised due to non-availability of requisite information.

### About the company

SKEPL, a special purpose vehicle (SPV) incorporated and owned by SIPL, has entered into 17 years CA (including construction period of 730 days from appointed date) with NHAI for the design, build, operate and transfer (DBOT) of 24.570 km road on a hybrid annuity basis. The project under consideration is a greenfield project for the construction of the eight-lane section of Vadodara Mumbai Expressway from Kim (Km 254.430) to Ankleshwar (Km. 279) in the state of Gujarat. The bid project cost for the project is Rs.1,404.00 crore while the total cost of the project is envisaged at Rs.1,575.70 crore to be funded through construction grant from NHAI of Rs.618.70 crore, debt of Rs.669 crore and balance through promoter's contribution. SKEPL received the appointed date on November 1, 2019, from NHAI.
