Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) has withdrawn the outstanding rating of 'CARE D' assigned to the instruments of Bajaj Hindusthan Sugar Limited (BHSL) with immediate effect following confirmation from the Debenture Trustee regarding full repayment/extinguishment of the existing OCDs.

The last rated amount of the OCDs was ₹3,483.25 crore. Subsequently, one instalment was repaid, reducing the outstanding amount to ₹3,215 crore (ISIN: INE306A08EV6). The repayment/extinguishment was carried out pursuant to the implementation of the Resolution Plan under RBI's June 7, 2019 Prudential Framework. The outstanding instruments have now been replaced through issuance of new OCDs under new ISIN: INE306A07135 with revised terms and conditions as approved under the Resolution Plan.

BHSL, a part of the 'Shishir Bajaj Group'. With an extensive network of 14 mills dotted across Uttar Pradesh in North India, the company has an aggregate sugarcane crushing capacity of 136,000 tonnes crushed per day (TCD). Apart from Sugar, BHSL is also a leading manufacturer of ethanol. It has six distilleries with capacity to produce 800 kiloliters per day (KLPD) of industrial alcohol and owns 14 co-generation plants having power generating capacity of 449 MW.
