Rationale & Key Rating Drivers

CARE Ratings Limited. (CareEdge Ratings) had, vide its press release dated March 06, 2025, placed the rating(s) of AMB Food Products (AFP) under the 'issuer non-cooperating' category as AFP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AFP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 20, 2026, January 30, 2026, February 09, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
