Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 04, 2025, placed the rating(s) of Hitech Competent Builders Private Limited (HCBPL) under the 'issuer non-cooperating' category as HCBPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. HCBPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 18, 2026, January 28, 2026, February 07, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to bank facilities of HCBPL have been revised on account of non – availability of requisite information.
