Rationale and key rating drivers

CARE Ratings Ltd. has withdrawn the outstanding rating of 'CARE BB Stable; ISSUER NOT COOPERATING' assigned to the bank facilities of Lord's Mark Industries Limited with immediate effect. The above action has been taken as the company is amalgamated post the approval of resolution plan as ordered by the Hon'ble National Company Law Tribunal (NCLT), principal bench, Mumbai vide order no. C.P. (IBPP) No. 03/MB/2023 pronounced on July 28, 2025, under the Insolvency & Bankruptcy Code.

It is also involved in supply and installation of solar home lighting system, solar streetlights and solar lantern for various government authorities. The Company has recently entered into Pharma division and has been appointed as the official channel partner for Cipla Healthcare Ltd for selling its OTC products in government sector Pan India.
