Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 28, 2025, placed the rating(s) of Aviral Education Welfare and Cultural Society (AEWCS) under the 'issuer non-cooperating' category as AEWCS had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AEWCS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 14, 2026, March 24, 2026, April 03, 2026 and May 21, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of AEWCS have been revised on account of non-availability of requisite information. The rating revision also considers default in debt servicing as recognized from possession notice issued by lender available from public domain.
