### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated March 18, 2025, placed the rating(s) of Mutyala Agro Tech LLP (MATL) under the 'issuer non-cooperating' category as MATL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MATL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 02, 2026, February 11, 2026, February 21, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The firm has been engaged in rice milling and processing business and it has commenced its operations from December 2015 onwards. The manufacturing plant of the firm is located at Bargarh, Orissa with aggregate installed capacity of 17520 metric ton per annum of rice milling and processing. Mr. M.V. V.
