Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated March 20, 2025, placed the rating(s) of Faba Agencies (FA) under the 'issuer non-cooperating' category as FA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. FA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 03, 2026, February 13, 2026, February 23, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of FA have been revised on account of non-availability of requisite information.
