Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 04, 2025, placed the rating(s) of Babanarayan Himghar Private Limited (BHPL) under the 'issuer non-cooperating' category as BHPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BHPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 18, 2026, February 28, 2026, March 10, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

Incorporated in January 2012, Babanarayan Himghar Private Limited (BHPL) was promoted by Mr Saikat Nandan and Mr Tapas Nanshi for setting up a cold storage facility. BHPL has started its commercial operations from March 2015. The company has been engaged in cold storage services for potatoes to farmers and traders on a rental basis. The coldstorage facility of the company is located at Paschim Midnapur in West Bengal with a storage capacity of 162200 quintals. Besides providing cold storage facility the company also works as a mediator between the farmers and marketers of potato, to facilitate sale of potatoes stored and it also provides interest bearing advances to farmers for farming purposes against potato stored.
