### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 29, 2025, placed the rating(s) of Flourish Paper & Chemicals Limited (FPCL) under the 'issuer non-cooperating' category as FPCL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. FPCL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 15, 2026, March 26, 2026, April 04, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the Company

Flourish Paper and Chemicals Limited (FPCL) incorporated in June 07, 1995, is being managed by Mr. Atul Mehra, Mrs. Sangeeta Mehra and Mr. Sanjay Mahajan. The company is engaged in manufacturing of AKD Emulsion and other allied chemicals used in the paper and textile industry at its manufacturing facility located in Derabassi, Punjab. In addition to this, FPCL has logistic business of chemical distribution. UP Alums Private Limited (UAP), the group entity of FPCL, was incorporated in January, 1992, however, commenced its commercial operations in July, 1998.

**Status of non-cooperation with previous CRA:** Acuite has continued the rating assigned to the bank facilities of FPCL into Issuer Not Cooperating category vide press release dated December 10, 2025 on account of its inability to carry out a review in the absence of requisite information.

ICRA has continued the rating assigned to the bank facilities of FPCL into Issuer Not Cooperating category vide press release dated July 28, 2025 on account of its inability to carry out a review in the absence of requisite information.
