### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings)) had, vide its press release dated April 01, 2025, placed the rating(s) of Aryavrata Steel Private Limited (ASPL) under the 'issuer non-cooperating' category as ASPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ASPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 15, 2026, February 25, 2026, March 07, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of ASPL have been revised on account of non-availability of requisite information.
