Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 07, 2025, placed the rating(s) of Madhav Solar (Vadodara Rooftop) Private Limited (MSRPL) under the 'issuer non-cooperating' category as MSRPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MSRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 21, 2026, March 03, 2026, March 13, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of MSRPL have been revised on account of non-availability of requisite information.

About the Company

In March 2014, MSRPL was incorporated as a subsidiary of WSL. Post dis-investment of entire shareholding (i.e. 51%) by WSL to third parties, MSRPL ceased to be a subsidiary of WSL w.e.f. January 18, 2024. MSRPL is now owned and managed by a group of individuals, collectively holding controlling stake in MSRPL. MSRPL had entered into a long-term PPA with MGVCCL for supply of the entire solar power generated for a period of 25 years at a tariff of Rs.10.76/unit. As per the terms of PPA, the scheduled commercial operation date (SCOD) for the project was March 31, 2015. MSRPL commissioned 28 sites till March 2015 and on receiving extension of SCOD from MGVCCL for three months, MSRPL commissioned additional 11 sites till June 2015.
