### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 17, 2025, placed the rating(s) of Rali Engineering Works (REW) under the 'issuer non-cooperating' category as REW had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. REW continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 03, 2026, March 13, 2026, March 23, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Mr Lenin is a registered PWD contractor.
