Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 07, 2025, placed the rating(s) of Saakar Infra Nirman Private Limited (SINPL) under the 'issuer non-cooperating' category as SINPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SINPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 21, 2026, March 03, 2026, March 13, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SINPL have been revised on account of non-availability of requisite information.
