### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 21, 2025, placed the rating(s) of Merrito Polymers (India) Private Limited (MPPL) under the 'issuer non-cooperating' category as MPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 07, 2026, March 17, 2026, March 27, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Merrito Polymers (India) Private Limited (MPPL) was incorporated in the year 2014 as a private limited company and promoted by Mr. Yesu Das Dovari, Mrs. Jayaprada Dovari, Mr. Dovari Amarnath and Mrs. Darsi Vanaja. The manufacturing unit of Vinyl Sheeting and Polyvinyl chloride Flexible Film and Foils is located in Krishna District, Andhra Pradesh, covering an area of ~3400 square feet. The company is engaged in manufacturing of Vinyl Sheeting and Polyvinyl Chloride Flexible film and started commercial operation from September 2017. The company purchases raw material (rigid film) from Chennai, Andhra Pradesh and Telangana. The company sells its final products to Maharashtra, Chennai, Telangana, Andhra Pradesh etc.
