Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 15, 2025, placed the rating(s) of Nirwan Charitable Trust (NCT) under the 'issuer non-cooperating' category as NCT had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NCT continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 01, 2026, March 11, 2026, March 21, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of NCT have been revised on account of non-availability of requisite information.

NCT was formed in February 1999 with an objective of imparting education in the field of health. The trust mainly operates four colleges viz. SNIPT (formed in 1999), RCN (formed in 2002), RDCH (formed in September 2003) and SNCP (formed in 2016). Further, in March 2017, NCT was promulgated as a private university through "The Nirwan University, Jaipur Act, 2017" by the legislative assembly of state of Rajasthan. The university, located at Bassi nearby Jaipur, Rajasthan will start operations from AY22. Furthermore, the trust also operates a blood bank in Sri Ganganagar in the name of 'Swastik Blood Bank'.
