Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated May 23, 2025, placed the rating(s) of Genus Paper and Coke Limited (GPCL) under the 'issuer non-cooperating' category as GPCL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GPCL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 08, 2026, April 18, 2026, April 28, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of GPCL have been revised on account of non-availability of requisite information.

About the company

Genus Paper and Coke Limited was incorporated as a wholly owned subsidiary of Genus Paper and Boards Limited on July 23, 2020. However, the company began its commercial production from May 01, 2021. The company is engaged in manufacturing of met coke with an installed manufacturing capacity of 96,000 M.T.P.A. as on June 30, 2022 at its manufacturing plant located in Chopadava, Bhachau, Gujarat (taken over from Yajur Commodities Limited). During the last quarter, GPBL has divested 100% of its equity stake and thus, GPCL ceased to be the Wholly Owned Subsidiary of the Company w.e.f. March 06, 2026.
