Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 10, 2025, placed the rating(s) of Jainco Enterprises Private Limited (JEPL) under the 'issuer non-cooperating' category as JEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 24, 2026, March 06, 2026, March 16, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of JEPL have been revised on account of non-availability of requisite information.

Kota (Rajasthan) based JEPL was originally formed as a proprietorship concern in 1984 by Mr. Rajendra Kumar Jain. Subsequently, it converted to partnership firm in 1995 and further, in 2011, it was again reconstituted as private limited company. JEPL is engaged in road construction and is registered as "AA" class approved contractor (Highest in the scale of AA to E) with PWD, Rajasthan and Madhya Pradesh indicating eligibility to bid for contracts of any amount. Further, JEPL has 48.96% stake in Special Purpose Vehicle (SPV), Chetak Jainco Tollways Limited in association with CEL.
