### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 11, 2025, placed the rating(s) of Akrati Technimont Limited (ATL) under the 'issuer non-cooperating' category as ATL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ATL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 25, 2026, March 07, 2026, March 17, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of ATL have been revised on account of non-availability of requisite information.
