Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 25, 2025, placed the rating(s) of Krishi Constructions Private Limited (KCPL) under the 'issuer non-cooperating' category as KCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 11, 2026, March 21, 2026, May 28, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Company

Krishi Constructions was established as a partnership firm in the year 1996. However, later in the year 2006 the firm was changed to private limited company viz. Krishi Constructions Private Limited (KCPL). KCPL is promoted by K. Koteswara Rao along with his wife Mrs. K. Sujatha at S.R. Nagar, Hyderabad, and Telangana. The company acts as the civil contractor for construction of buildings, dams, roads and all types of civil works for state governments like Andhra Pradesh, Telangana.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of KCPL to the 'issuer not-cooperating' category vide press release dated December 22, 2025 on account of its inability to carryout review in the absence of requisite information from the company.
