Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated May 02, 2025, placed the rating(s) of Airtec Electrovision Private Limited (AEPL) under the 'issuer non-cooperating' category as AEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 18, 2026, March 28, 2026, April 07, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Delhi-based Airtec Electrovision Private Limited (AEPL) was incorporated in 2016 by Mr Manish Nathani and Ms Varsha Nathani. AEPL is engaged in trading and assembling of electrical goods such as LED televisions, DVD player and speakers etc. The company purchases the traded goods from the local distributors situated in Delhi NCR region. The company sells its products pan India through its distributor network. Beston Electrovision Private limited is an associate concern of AEPL; engaged in manufacturing and trading of electrical goods such as LED televisions, DVD player, Speakers.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of AEPL into 'Issuer not-cooperating' category vide press release dated November 12, 2025, on account of non-availability of requisite information from the company.
