### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 14, 2025, placed the rating(s) of Paramount Speciality Forgings Limited (PSFL) under the 'issuer non-cooperating' category as PSFL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PSFL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 28, 2026, March 10, 2026, March 20, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of PSFL have been revised on account of non-availability of requisite information.

### About the company

Paramount Speciality Forgings Limited (PSFL) was initially established as partnership firm named Paramount Forge (PF) in 1996. Further, During the year 2020, the constitution of the firm has changed to Limited Liability Partnership firm under the name of Paramount Speciality Forgings LLP. Consequently, During May, 2023, constitution of company has been changed and name of the company has been changed to PSFL. PSFL got listed at NSE-SME (ISIN: INE0Q6001012) on September 2024. The company is managed by Bhagat and Hararwala family and is engaged in the business of manufacturing & exports of carbon steel, stainless steel, and alloy steel forged flanges used in pipe fittings. PSFL primarily sell products to oil and gas, petrochemicals and allied industries with exports to various countries across Oman, Canada, Italy, United Kingdom contributed. It procures primary raw materials viz. stainless steel (SS) bars, billets, rounds and mild steel (MS) plates, rounds, etc. entirely from domestic market. The firm operates through its two-plant located at Kamothe near Panvel and Khalapur near Khopoli, Maharashtra which is ISO 9001:2008 certified. The administrative office located at Mazagaon, Mumbai.
