Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated May 07, 2025, placed the rating(s) of Iscon Craft Paper Mill Private Limited (ICPMPL) under the 'issuer non-cooperating' category as ICPMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ICPMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 23, 2026, April 02, 2026, April 12, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Company

Vadodara-based (Gujarat) 'Iscon Craft Paper Private Limited' (ICPMPL) was incorporated in September 2011. ICPMPL is engaged into manufacturing of absorbent craft paper which is used as raw material in lamination industry from its sole manufacturing facility located at Karjan, Vadodara with an installed capacity of 140 Mt per day as on March 31, 2019.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of ICPMPL into Issuer Not Cooperating category vide press release dated September 26, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
