Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated September 01, 2025, placed the rating(s) of Purv Flexipack Limited (PFL) under the 'issuer non-cooperating' category as PFL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PFL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 28, 2026, May 29, 2026 and June 01, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of PFL have been revised on account of non-availability of requisite information.

This apart, company is engaged in the trading of Masterbatch, Ink and Adhesives (used for making thin films) and titanium dioxide, etc.
