Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 14, 2025, placed the rating(s) of Kalosona Himghar Udyog Private Limited (KHUPL) under the 'issuer non-cooperating' category as KHUPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KHUPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 28, 2026, March 10, 2026, March 20, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

Kalosona Himghar Udyog Private Limited. (KHUPL), incorporated in the year 2004, is a Arambagh (West Bengal) based company, promoted by Mr. Priyo Mohan Dey and Mr. Mukti Podho Kundu. It is engaged in the business of providing cold storage services to potato growing farmers and potato traders, having an installed storage capacity of 170,000 quintals in Hooghly district of West Bengal. Mr. Mukti Padho Kundu and Mr. Priyo Mohan Dey, both having experience of more than three decades, look after overall management of the company. Both directors are supported by other two directors and a team of experienced professionals who have rich experience in the same line of business.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of KHUPL into ISSUER NOT COOPERATING category vide press release dated December 10, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
