### Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 15, 2025, placed the rating(s) of S. Sagar Enterprise (SSE) under the 'issuer non-cooperating' category as SSE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 01, 2026, March 11, 2026, March 21, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.
