Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 03, 2025, placed the rating(s) of Aloke Steels Industries Private Limited (ASIPL) under the 'issuer non-cooperating' category as ASIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ASIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 17, 2026, February 27, 2026, March 09, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of ASIPL have been revised on account of non-availability of requisite information.

About the company

ASIPL, incorporated in 2004, was promoted by Jharkhand based Mr. Ram Chandra Rungta. The company is engaged in the manufacturing of sponge iron at its plant located in Ramgarh, Jharkhand with an installed capacity of 120,000 MTPA. Other companies belonging to the RC Rungta group are Jharkhand Ispat Pvt. Ltd. engaged in the manufacturing of sponge iron and MS Billets and Maa Chhinnmastika Cement & Ispat Pvt. Ltd. engaged in the manufacturing of sponge iron. The aggregate installed capacity of the group for sponge iron is 3,30,000 MTPA and for billets is 78,990 MTPA. The group has also formed various Joint Ventures to carry on coal mining and handling activities for Mahanadi Coalfields Ltd.
