Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated May 08, 2025, placed the rating(s) of Ideas Electricals & Engineers Private Limited (IEEPL) under the 'issuer non-cooperating' category as IEEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. IEEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 24, 2026, April 03, 2026, April 14, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to bank facilities of IEEPL have been revised on account of non-availability of requisite information.

Established in 2008, Ideas Engineers as a partnership entity, which was reconstituted in December 2018 as a private limited company i.e., Ideas Electricals & Engineers Private Limited (IEEPL). The company is managed by three directors Mr. Subhash R. Sarda, Mr. Sunil B. Gadekar and Mr. Virendra Pratap Singh. IEEPL is an Aurangabad based company engaged in the business of Engineering, Procurement and Construction (EPC) contractor for electrical projects for various industries including sugar, cement, fertilizer, metallurgical plants and all others areas. The company is also into supply of electrical control panels, low voltage Power control Centre (PCC), Motor Control Centre (MCC), distribution Boards, Bus-Ducts & Control Desks coupled with designing, detail engineering and drawing of electrical installation.

Status of non-cooperation with previous CRA: India Ratings has continued the rating assigned to the bank facilities of IEEPL under Issuer Not Cooperating category vide press release dated April 02, 2026 on account of its inability to carry out a review in the absence of the requisite information from the company.
