### Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated May 28, 2025, placed the rating(s) of Remira Motors Private Limited (RMPL) under the 'issuer non-cooperating' category as RMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 14, 2026, April 23, 2026, May 03, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the company

Remira Motors Private Limited (RMPL) was incorporated in March 2016 as a private limited company and is currently being managed by Mr. Amit Singh Brar and Mr. Jagmohan Singh Brar. RMPL commenced commercial operations in July 2016. The company is an authorised dealer of passenger and utility vehicles of Maruti Suzuki India Limited. RMPL operates a 3S facility (sales, spares and service) and is also engaged in purchase and sale of preowned cars at its showroom/ workshop located at Moga (Punjab). Besides DOPL, the directors are also associated with another group concerns namely Bel Nutrition Private Limited and Brar Enterprises Limited.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of RMPL into Issuer Not Cooperating category vide press release dated December 22, 2025 on account of its inability to carry out a review in the absence of requisite information.
