Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated March 19, 2025, placed the rating(s) of Kirloskar Electric Company Limited (KECL) under the 'issuer non-cooperating' category as KECL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KECL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 02, 2026, February 12, 2026, February 22, 2026 among others. In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of KECL have been revised on account of non-availability of requisite information.

Headquartered in Bengaluru, KECL (ISIN: INE134B01017) was incorporated in 1946. In its past seven decades of existence, the company has established itself as one of the major players in the domestic electric equipment industry. KECL is engaged in manufacturing AC motors, DC motors, transformers, switchgear, and electronics through six manufacturing units. The company's day-to-day operations are looked after by Vijay Kirloskar (Chairman), who is adequately supported by a group of professionals having rich business experience. NCLT vide order dated April 30, 2026 approved the merger of Company's Wholly owned subsidiaries Kelbuzz Trading Private Limited, SKG Terra Promenade Private Limited, SLPKG Estate Holdings Private Limited and Luxquisite Parkland Private Limited with the Holding company. The effective date of Merger is April 1, 2024.
