Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 14, 2025, placed the rating(s) of Saraya Industries Limited (SIL) under the 'issuer non-cooperating' category as SIL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SIL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 28, 2026, March 10, 2026, March 20, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Saraya Industries Ltd. (SIL), promoted by the Majithia family was originally incorporated as a partnership firm in 1949 which was subsequently converted into a private limited company and later on into limited company in 1989. SIL is engaged in the business of manufacturing, sugar, country liquor, Indian Made Foreign Liquor (IMFL), industrial alcohol and co-generation of power.

Status of non-cooperation with previous CRA: India Ratings has continued the rating assigned to the bank facilities of SIL into Issuer Not Cooperating category vide press release dated July 18, 2025 on account of its inability to carry out a review in the absence of requisite information.
