Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 07, 2025, placed the rating(s) of Kamineni Health Care Private Limited (KHCPL) under the 'issuer non-cooperating' category as KHCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KHCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 21, 2026, March 03, 2026, March 13, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of KHCPL have been revised on account of non-availability of requisite information.

About the company

KHCPL was originally incorporated as Kamineni Infra Ventures Private Limited in 2007 and was renamed to its current name in 2013. Promoted by Kamineni Shashidhar, the hospital commenced operations in August 2014 with the establishment of a superspeciality hospital in Vijayawada, Andhra Pradesh. Currently, KHCPL operates with a capacity of 330 beds, including 78 Intensive Care Unit (ICU) beds, 45 for critical care, and 207 in the general ward, with an operational capacity of 250 beds. The hospital is equipped with state-of-the-art medical technology and staffed by highly qualified and experienced doctors and surgeons. KHCPL is a part of the Hyderabad-based Kamineni Group, a key player in the healthcare sector.

The group also operates Kamineni Hospitals, a 1,200-bed multi-speciality hospital in Hyderabad, which has been in operation since 1995. Kamineni Hospitals provide comprehensive medical care across multiple specialities, including cardiology, neurology, gastroenterology, pulmonology, nephrology, orthopaedics, and critical care.
