Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated May 29, 2025, placed the rating(s) of Omsairam Steels and Alloys Private Limited (OSAPL) under the 'issuer non-cooperating' category as OSAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OSAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 14, 2026, April 24, 2026, May 04, 2026, among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

The ratings assigned to bank facilities of OSAPL have been revised on account of non-availability of requisite information.

The shareholding of the group is closely held by family members with directors being Mr. Dinesh Bharuka, Mr. Rajendra Bharuka, Mr. Jawaharlal Dembada and Mr. Sanjeev Kumar Kabra. OSAPL was acquired by the Bharuka family in 2006 from Mr. Agarwal. Originally the Bharuka family was involved in steel scrap business for past 40 years.
